The purpose of battering is to instill fear, intimidate, and control behavior not to leave bruises. Some of the most effective batterers do not beat: they do not need to, at least not very often. Threats and hostile looks serve the same purpose: to control behavior through fear and to keep the victim trapped in the Cycle of Violence.

# Teen & Adult "Dating Contract"

Dating teens must have a parent present to discuss abuses & consequences. Dating adults must have the female's relative/friend present to discuss abuses & consequences.

Both parties may stop seeing each other at any time for any reason. This relationship and contract will be immediately terminated for any abuses and criminal charges reported for any physical/sexual abuse or threats. A Restraining Order will also be requested.

**\*Physical Abuse -** Violence which may or may not result in any injury from beating, biting, choking, grabbing, hitting, pushing, slapping, restraining, scratching, shaking, shoving, pinching, using weapons, spanking, stalking, physical contact which may present a physical/emotional problem, etc.

**\*Sexual Abuse -** Makes her/him do sexual acts against her/his will, touching, kissing, hugging/holding, forced sex, attacking the private parts of her/his body, etc.

**Verbal Abuse** - Name calling, yelling, insults, being sarcastic, threatening violence to her and /or children, belittling, etc.

**Emotional Abuse -** Put-downs, name calling, belittling, insults, threats, using drugs/alcohol, intense jealousy, manipulating with lies, using mind games, keeping her/him from going to school/work, ignoring her/him, laughing at her/him all the time, making her/him think she/he is crazy, insulting her/his family/friends, etc.

#### A safety, protection, and escape plan should be developed by dating teens and adults. \*These acts will be reported to the police immediately and the victim must seek safety and protection away from the batterer/abuser until his/her arrest.

Hicks is called the "Godfather" of domestic violence prevention because of his success in treating batterers and abusers who have extensive criminal histories. His theme, "Rehabilitation Through Devastation" has been enthusiastically echoed throughout the domestic violence prevention community.

Hicks was inducted into the Social Work Hall of Fame in 2008 by the University of Kentucky.

For the past seven years Hicks has lectured at high schools, colleges, community agencies, public/private organizations, hospitals, churches, parent teacher associations, state prisons, county and city jails, domestic violence workshops, probation/parole departments, military bases, police departments, child protection agencies, senior citizen centers, children with special needs agencies, victims' groups, batterers' groups, county and state agencies, various drug/alcohol treatment programs for youths/adults, and the Los Angeles County Grand Jury.

for reducing domestic violence and divorce. Domestic violence occurs in same sex relationships with the same frequency and severity as opposite sex relationships.

Topics with an **\*asterisk** will not be discussed unless requested by the event host.

- Mandatory Psychiatric Exam on all convicted batterers
- Convicted batterers should never have access or **possession of weapons**
- Batterers should **not contact** the victim and/or children until successfully completing a 52 Week Domestic Violence Treatment Program
- Teen Dating Contract & Adult Dating Contract
- Securing a **Criminal Record Report** on Adults and Teens who are dating
- GPS (Global Positioning System) connected to all convicted batterers and individuals with a Restraining Order against them until completion of a 52 week Domestic Violence Treatment Program 26 52 Week DV program for all individuals arrested for domestic violence (convicted or not). Victim must attend a victims' group (4 6 weeks) even if she drops the charges
- **National Registry:** Marriage, Divorce, individuals convicted of domestic violence, and individuals that have or ever had a Domestic Violence Restraining Order against them
- \* **Polygraph Test** admitted in domestic violence court proceedings when the victim changes her/his story
- \* **Fines** and/or **Restraining Order** filed against the batterer if the victim changes her/his story
- \* If a batterer is convicted of battering his wife their **marriage** is automatically **annulled**
- \* Marriage License Renewal, Expiration, Expunged, Annulled, Pre-Nuptial Agreements


